Criminal justice cases involving domestic abuse (N=8170) with a specific focus on intimate partner violence cases (N=5761)

- Crimes against human life and health, violation of the right to personal liberty and the right to protect personal safety, breaches of personal privacy correspondence, crimes against humanity, offenses against the family, and crimes against children, among others.
- Spouses, ex-spouses, unmarried couples (long-term cohabitation)



The Violenceoff project (violenceoff.cz) aims to map and describe the treatment of perpetrators involved in cases of domestic gender-based violence in the Czech Republic. Additionally, the project aims to identify shortcomings and best practices in this area, as well as the needs of the key stakeholders. Based on these findings, the project proposes effective measures to establish a system for working with offenders of domestic and gender-based violence (DGBV).





- According to the data, approximately one-sixth of all cases were related to alcohol, while the use of other narcotics and psychotropic substances was reported on rare occasions.
- In less than one-tenth of the cases, the victim was a child.
- More than half of the cases resulted in suspended sentences, with an average sentence length of 20 months and a probationary period of 33 months.
- Nearly two-thirds of the offenders had previous convictions, but only 5% of them were labeled as particularly dangerous recidivists by the court.





No sentence - other reasons = the sentence was not imposed for the following possible reasons: suspension or certification after conditional cessation of criminal prosecution according to §308 of the Criminal Code and less often transfer or settlement approval.

- Intimate partner violence during the observed period predominantly involved the abuse of a person residing in a shared residence. About 36% of cases were classified as abuse alone, without the occurrence of any other crime. Among the convicted individuals, more than half received suspended sentences.
- When abuse\* occurred alongside other offenses, it was most commonly associated with maltreatment of an entrusted person, threats, extortion, or rape.
- The largest proportion (44%) of offenders who received suspended sentences were those who committed both maltreatment\* and extortion.
- Conversely, the highest number of acquittals (19%) occurred when abuse\* was accompanied by rape.
- In addition to abuse\*, intimate partner violence also involved other criminal activities such as threats, bodily harm (including grievous harm), and extortion.
- Imprisonment was most often imposed for grievous bodily harm. In other cases, the court imposed a suspended sentence (more than half of the cases).
- The graphs presented in the analysis compare instances where individuals were tried solely for a specific crime versus combinations of these crimes.
